What has to be reported? (Alabama)	ALA. CODE 1975 § 26-14-3 (West 2013) (a) When the child is known or suspected to be a victim of child abuse or neglect.
Relevant Definitions (Alabama)	ALA. CODE 1975 § 26-14-1 (West 2013) (3) “Child” means a person under the age of 18 years. ALA. CODE 1975 § 26-14-1 (West 2013) (1) “Abuse” means harm or threatened harm to a child's health or welfare. Harm or threatened harm to a child's health or welfare can occur through nonaccidental physical or mental injury, sexual abuse or attempted sexual abuse or sexual exploitation or attempted sexual exploitation. "Sexual abuse" includes the employment, use, persuasion, inducement, enticement, or coercion of any child to engage in, or having a child assist any other person to engage in any sexually explicit conduct or any simulation of the conduct for the purpose of producing any visual depiction of the conduct; or the rape, molestation, prostitution, or other form of sexual exploitation of children, or incest with children as those acts are defined by Alabama law. "Sexual exploitation" includes allowing, permitting, or encouraging a child to engage in prostitution and allowing, permitting, encouraging or engaging in the obscene or pornographic photographing, filming, or depicting of a child for commercial purposes. (2) “Neglect” means negligent treatment or maltreatment of a child, including the failure to provide adequate food, medical

Private mental health center was not state actor for purposes of 42 U.S.C.A. § 1983 where it reported allegations made by plaintiff's ex-wife that plaintiff had abused his children; center was required by state law to report such allegations. <i>Barber v. CODE 1975 § 26-14-13 (West 2013)</p> <p>Any person who shall knowingly fail to make the report required by this chapter shall be guilty of a misdemeanor and shall be punished by a sentence of not more than six months' imprisonment or a fine of not more than \$500.00.</p>

What has to be reported? <i>(Alaska)</i>	ALASKA STAT. § 47.24.010 (2013) (a) Reasonable cause to believe that in the performance of their professional duties a vulnerable adult suffers from abandonment, exploitation, abuse, neglect, or self-neglect.
Relevant Definitions <i>(Alaska)</i>	ALASKA STAT. § 47.24.900 (2013) (1) “Abandonment” means desertion of a vulnerable adult by a caregiver. (2) “Abuse” means: (A) the intentional, knowing, or reckless nonaccidental, and nontherapeutic infliction of physical pain, injury, or mental or emotional distress; or (B) sexual assault. (7) Exploitation means unjust or improper use of another person or another person's resources for one's own profit or advantage. ANN. § 13-3620 (2013) (A) Any person who reasonably believes that a minor is or has been the victim of physical injury, abuse, child abuse, a reportable offense or neglect that appears to have been inflicted on the minor by other than accidental means or that is not explained by the available medical history as being accidental in nature or who reasonably believes there has been a denial or deprivation of necessary medical treatment or surgical care or nourishment with the intent to cause or allow the death of an infant who is protected under § 36-2281.
